RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE VI AND THE CITY GOVERNMENT FOR THE IMPLEMENTATION OF SCHOLARSHIP PROGRAM CHARGEABLE AGAINST THE PRIORITY DEVELOPMENT ASSISTANCE FUND (PDAF) OF SENATOR LOREN LEGARDA AMOUNTING TO TWO HUNDRED THOUSAND PESOS ONLY (P 200,000.00).
