RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND NOEL BAJAN AS MEDICAL EQUIPMENT TECHNICIAN AT BAGO CITY HOSPITAL FOR THE REPAIR AND MAINTENANCE OF HOSPITAL EQUIPMENTS IN COMPLIANCE WITH THE REQUIREMENT OF THE DEPARTMENT OF HEALTH AND PHILHEALTH.
