RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF HEALTH, CENTER FOR HEALTH DEVELOPMENT (DOH-CHD) – WESTERN VISAYAS IN THE IMPLEMENTATION OF THE UNIFIED HEALTH MANAGEMENT INFORMATION SYSTEM (UHMIS) THAT WILL INTEGRATE OR HARMONIZE DATA COLLECTION, PROCESSING, REPORTING, AND USE OF INFORMATION WHICH IS NECESSARY FOR IMPROVING HEALTH SERVICE EFFICIENCY AND EFFECTIVENESS.
