RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND NEGROS ELECTRICAL SERVICES FOR PROVIDING FOUR (4) UNITS GENERATING SETS FOR THE 2013 LOCAL AND NATIONAL ELECTIONS AS STANDBY UNITS IN CASE OF BROWNOUT AND FOR EMERGENCY PURPOSES.

WHEREAS, in a letter dated June 4, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and Negros Electrical Services for providing four (4) units generating sets for the 2013 local and national elections as standby units in case of brownout and for emergency purposes;

WHEREAS, after a thorough deliberation, the members of this Honorable Body is of the consensus to approve the said matter;
