RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, BARANGAY CONCERNED, A BONAFIDE RESIDENT OF BARANGAY CONCERNED AND THE BAGO CITY EMPLOYEE'S COOPERATIVE FOR THE IMPLEMENTATION OF A MULTI-PARTITE ECOLOGICALLY-BALANCED AND SUSTAINABLE AGRICULTURE PROJECT.
