## **RESOLUTION NO. 13-106**

RESOLUTION APPROVING THE REQUEST OF MA-AO ELEMENTARY SCHOOL TEACHER'S LEAGUE FOR THE TRANSFER BACK OF THE MONUMENT OF DR. JOSE P. RIZAL FROM ITS PRESENT LOCATION AT THE BARANGAY MA-AO PUBLIC PLAZA TO THE MA-AO ELEMENTARY SCHOOL.

**WHEREAS,** the Administrator and Faculty of Ma-ao Elementary School passed a Resolution requesting for the transfer of the monument of Dr. Jose P. Rizal from its present location at the Barangay Ma-ao Public Plaza to the Ma-ao Elementary School;

**WHEREAS**, Ma-ao Elementary School plans to build a Rizal Park to further emphasize the teachings of the life and works of Dr. Jose P. Rizal;

**WHEREAS,** as an educational institution, Ma-ao Elementary School can use the monument as an educational tool to teach children to emulate the heroic traits of the national hero;

**WHEREAS**, the Barangay Council of Barangay Ma-ao itself has passed a resolution endorsing the transfer of the Monument of Dr. Jose P. Rizal to Ma-ao Elementary School;

**WHEREAS,** after a thorough deliberation, the members of this Honorable Body is of the consensus to approve the said matter;
