RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND RAFAEL M. SALAS PARKS AND NATURE CENTER (RMSPNC) FOUNDATION, INC., FOR THE JOINT UNDERTAKING OF THE REPAIRS, RENOVATION AND REFURBISHMENT OF THE PAVILION (HEREINAFTER REFERRED TO AS THE 3Rs PROJECT) INSIDE THE RAFAEL M. SALAS PARKS AND NATURE CENTER.

WHEREAS, in a letter dated June 17, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and Rafael M. Salas Parks and Nature Center (RMSPNC) Foundation, Inc., for the joint undertaking of the repairs, renovation and refurbishment of the pavilion (hereinafter referred to as the 3Rs Project) inside the Rafael M. Salas Parks and Nature Center;
