## **RESOLUTION NO. 13-122**

RESOLUTION GRANTING AUTHORITY TO GORGONIO T. PARROCO, Ph.D., COLLEGE ADMINISTRATOR, BAGO CITY COLLEGE, THIS CITY TO PRIVATELY PRACTICE HIS PROFESSION SUBJECT TO CONDITIONS.

**WHEREAS,** in a letter dated July 3, 2013 from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, requesting from this Honorable Body to pass a resolution granting authority to Gorgonio T. Parroco, Ph.D., College Administrator, Bago City College, this City to privately practice his profession subject to the following conditions, to wit:

- 1. That his practice of profession shall not conflict nor tend to conflict with the functions of his office;
- 2. That his private practice of profession shall be done strictly outside of the office hours and shall not in any way interfere with the performance of his official functions and duties;
- 3. That the authority granted is for one (1) year subject to renewal upon the recommendation of the City Mayor;
- 4. That the City Mayor reserves the right to revoke the authority when the exigency of the service so demands.

WHEREAS, after deliberation on the matter, it is the consensus of this assembly to grant said request;

**NOW, THEREFORE,** upon motion of SP Member Bernadette M. Somcio, duly seconded by SP Member Andrew Martin Y. Torres, the Sanggunian

**RESOLVES**, as it is hereby resolved, to grant authority to Gorgonio T. Parroco, Ph.D., College Administrator, Bago City College, this City to privately practice his profession subject to conditions.
