## **RESOLUTION NO. 13-123**

## RESOLUTION GRANTING AUTHORITY TO DR. DEBORAH NATALIA E. SINGSON, COLLEGE DEPARTMENT HEAD, BAGO CITY COLLEGE, THIS CITY TO PRIVATELY PRACTICE HER PROFESSION SUBJECT TO CONDITIONS.

**WHEREAS,** in a letter dated July 3, 2013 from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, requesting from this Honorable Body to pass a resolution granting authority to Dr. Deborah Natalia E. Singson, College Department Head, Bago City College, this City to privately practice her profession subject to the following conditions, to wit:

- 1. That her practice of profession shall not conflict nor tend to conflict with the functions of her office;
- 2. That her private practice of profession shall be done strictly outside of the office hours and shall not in any way interfere with the performance of her official functions and duties;
- 3. That the authority granted is for one (1) year subject to renewal upon the recommendation of the City Mayor;
- 4. That the City Mayor reserves the right to revoke the authority when the exigency of the service so demands.

WHEREAS, after deliberation on the matter, it is the consensus of this assembly to grant said request;

**NOW, THEREFORE,** upon motion of SP Member Bernadette M. Somcio, duly seconded by SP Member Andrew Martin Y. Torres, the Sanggunian

**RESOLVES,** as it is hereby resolved, to grant authority to Dr. Deborah Natalia E. Singson, College Department Head, Bago City College, this City to privately practice her profession subject to conditions.
