RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A LETTER OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, BACOLOD CITY FOR THE PROVISION OF FUNDS FROM THE NATIONAL GREENING PROGRAM FOR THE SERVICES OF THE CITY FOR THE 2ND YEAR MAINTENANCE AND PROTECTION OF 5.0 HECTARES URBAN GREENING LOCATED AT BARANGAYS BALINGASAG AND LAG-ASAN, BOTH OF THIS CITY.

WHEREAS, in a letter dated June 22, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in a Letter of Agreement to be executed by and between the City Government of Bago and the Department of Environment and Natural Resources, Bacolod City for the provision of funds from the National Greening Program for the services of the City for the 2nd year maintenance and protection of 5.0 hectares urban greening located at Barangays Balingasag and Lag-asan, both of this City;
