RESOLUTION ADOPTING ADMINISTRATIVE ORDER NO. 2007-0018 OF THE DEPARTMENT OF HEALTH, SUBJECT: NATIONAL POLICY ON THE MANAGEMENT OF THE DEAD AND THE MISSING PERSONS DURING EMERGENCIES AND DISASTERS.

WHEREAS, presented in session assembled is the Administrative Order No. 2007-0018 of the Department of Health pertaining to National Policy on the Management of the Dead and the Missing Persons during Emergencies and Disasters;

WHEREAS, this policy is very useful for authorities responsible for disaster prevention and response to avoid controversy on handling mass fatalities and effectively manage corpses and preserve the dignity of those who have passed;

WHEREAS, after a thorough deliberation, the members of this Honorable Body is of the consensus to adopt the said Administrative Order of the Department of Health;
