RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF AGRICULTURE RFU-VI FOR THE IMPLEMENTATION OF THE KARABAG-O (A CARABAO DEVELOPMENT PROGRAM IN BAGO CITY) UNDER THE BOTTOM-UP BUDGETING (BUB) PROGRAM.
