RESOLUTION APPROVING THE REALIGNMENT OF P4,750,000.00 FROM THE UNEXPENDED APPROPRIATIONS FOR THE 2010 LAND ACQUISITION FOR RESETTLEMENT, RELOCATION SITES AND SOCIALIZED HOUSING (P4,000,000.00) AND 2013 REHABILITATION OF RURAL HEALTH UNITS AND HOSPITAL (P750,000.00) TO (1) CONSTRUCTION/REHABILITATION/REPAIR OF LOCAL ROADS AND BRIDGES-P4,000,000.00, AND (2) CONSTRUCTION/REHABILITATION/REPAIR OF LOCAL GOVERNMENT POTABLE WATER SYSTEM-P750,000.00.

WHEREAS, in an Indorsement letter dated August 6, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body, Resolution No. 02, Series of 2013 of the Executive Committee, City Development Council, this City, requesting for approval, the realignment of P4,750,000.00 from the Unexpended appropriations for the 2010 Land Acquisition for Resettlement, Relocation Sites and Socialized Housing (P4,000,000.00) and 2013 Rehabilitation of Rural Health Units and Hospital (P750,000.00) to (1) Construction/Rehabilitation/Repair of Local Roads and Bridges-P4,000,000.00, and (2) Construction/Rehabilitation/Repair of Local Government Potable Water System-P750,000.00;
