GO FOR HIS SERVICES AS RADIOLOGIST TO PROVIDE EXPERTISE IN MEDICAL EVALUATION AND READING OF X-RAY FILMS FROM THE BAGO CITY HOSPITAL AND BAGO CITY HEALTH OFFICE.

WHEREAS, a letter dated September 10, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and Dr. Mario A.
