**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, VILLANUEVA CLINICAL LABORATORY & POLYCLINIC AND THE NEW BLOOD CHANNEL TO CATER LABORATORY TEST/EXAMINATIONS WHICH ARE NOT AVAILABLE AT THE BAGO CITY HOSPITAL LABORATORY AS A REQUIREMENT FOR THE RENEWAL OF THE LICENSE OF BAGO CITY HOSPITAL WITH THE DEPARTMENT OF HEALTH.**

**WHEREAS**, letter dated September 23, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and among the City Government of Bago, Villanueva Clinical Laboratory & Polyclinic and the New Blood Channel to cater laboratory test/examinations which are not available at the Bago City Hospital Laboratory as a requirement for the renewal of the license of Bago City Hospital with the Department of Health;
