## **RESOLUTION NO. 13-244**

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, VILLANUEVA CLINICAL LABORATORY & POLYCLINIC AND THE NEW BLOOD CHANNEL TO CATER LABORATORY TEST/EXAMINATIONS WHICH ARE NOT AVAILABLE AT THE BAGO CITY HOSPITAL LABORATORY AS A REQUIREMENT FOR THE RENEWAL OF THE LICENSE OF BAGO CITY HOSPITAL WITH THE DEPARTMENT OF HEALTH.

WHEREAS, letter dated September 23, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and among the City Government of Bago, Villanueva Clinical Laboratory & Polyclinic and the New Blood Channel to cater laboratory test/examinations which are not available at the Bago City Hospital Laboratory as a requirement for the renewal of the license of Bago City Hospital with the Department of Health;
