**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES REGION VI, PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF BAGO IN CONNECTION WITH THE PROTECTION AND MANAGEMENT OF FORESTLANDS PARTICULARLY THE MANAGEMENT OF MANGROVE AREAS AROUND BAGO CITY.**

**WHEREAS**, letter dated October 16, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City Government of Bago in a Memorandum of Agreement to be executed by and among the Department of Environment and Natural Resources Region VI, Provincial Government of Negros Occidental and the City Government of Bago in connection with the protection and management of forestlands particularly the management of mangrove areas around Bago City;
