RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF UNDERSTANDING TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, DEPARTMENT OF LABOR AND EMPLOYMENT – REGIONAL OFFICE VI, PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION, OVERSEAS WORKERS WELFARE ADMINISTRATION AND TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY – REGION VI FOR A CONVERGENCE IN ADVOCATING THE RIGHTS AND WELFARE OF OVERSEAS FILIPINO WORKER, TO TAKE A PROACTIVE STANCE BY BEING THE PRIMARILY RESPONSIBLE FOR THE DISSEMINATION OF INFORMATION TO THE CONSTITUENTS ON ALL ASPECTS OF OVERSEAS EMPLOYMENT PURSUANT TO REPUBLIC ACT NO. 10022.

WHEREAS, letter dated October 16, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City Government of Bago in a Memorandum of Understanding to be executed by and among the City Government of Bago, Department of Labor and Employment – Regional Office VI, Philippine Overseas Employment Administration, Overseas Workers Welfare Administration and Technical Education and Skills Development Authority – Region VI for a convergence in advocating the rights and welfare of overseas Filipino Worker, to take a proactive stance by being the primarily responsible for the dissemination of information to the constituents on all aspects of overseas employment pursuant to Republic Act No. 10022;
