**RESOLUTION NO. 13-259**

**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF UNDERSTANDING TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, DEPARTMENT OF LABOR AND EMPLOYMENT – REGIONAL OFFICE VI, PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION, OVERSEAS WORKERS WELFARE ADMINISTRATION AND TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY – REGION VI FOR A CONVERGENCE IN ADVOCATING THE RIGHTS AND WELFARE OF OVERSEAS FILIPINO WORKER, TO TAKE A PROACTIVE STANCE BY BEING THE PRIMARILY RESPONSIBLE FOR THE DISSEMINATION OF INFORMATION TO THE CONSTITUENTS ON ALL ASPECTS OF OVERSEAS EMPLOYMENT PURSUANT TO REPUBLIC ACT NO. 10022.**

**WHEREAS**, letter dated October 16, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City Government of Bago in a Memorandum of Understanding to be executed by and among the City Government of Bago, Department of Labor and Employment – Regional Office VI, Philippine Overseas Employment Administration, Overseas Workers Welfare Administration and Technical Education and Skills Development Authority – Region VI for a convergence in advocating the rights and welfare of overseas Filipino Worker, to take a proactive stance by being the primarily responsible for the dissemination of information to the constituents on all aspects of overseas employment pursuant to Republic Act No. 10022;
