RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF AGRICULTURE RFU-VI, CITY GOVERNMENT OF BAGO AND MAILUM ORGANIC VILLAGE ASSOCIATION FOR PROVIDING ONE (1) UNIT CASSAVA GRATER AS GRANT TO THE LOCAL GOVERNMENT UNIT.

WHEREAS, letter dated November 12, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City Government of Bago in the Memorandum of Agreement to be executed by and among the Department of Agriculture RFU-VI, City Government of Bago and Mailum Organic Village Association for providing one (1) unit Cassava Grater as grant to the Local Government Unit;
