## **RESOLUTION NO. 13-279**

## RESOLUTION DECLARING A STATE OF CALAMITY IN THE CITY OF BAGO, NEGROS OCCIDENTAL DUE TO DAMAGES CAUSED BY SUPER TYPHOON "YOLANDA".

**WHEREAS,** last November 8, 2013, Super Typhoon "Yolanda" struck Bago City and the entire Negros Occidental;

WHEREAS, Fifteen (15) Barangays in Bago City were badly hit and 1,335 families or 5,700 people have been evacuated;

WHEREAS, based on the initial report by the City Disaster Risk Reduction Management Council (CDRRMC), this City, the damage on property, agriculture and infrastructure was pegged at PHp 29,506,990.00;

WHEREAS, considering of the damages brought about by Super Typhoon "Yolanda", the members of this Honorable Body is of the consensus to declared Bago City, Negros Occidental under a state of calamity as recommended by Resolution No. 2013-07 of the City Disaster Risk Reduction Management Council (CDRRMC), this City;

**NOW, THEREFORE,** upon motion of SP Member Allan C. Galunan, unanimously seconded by SP Members present, the Sangguniang Panlungsod

**RESOLVES,** as it is hereby resolved, to declare a State of Calamity in the City of Bago due to damages caused by Super Typhoon "Yolanda".

**RESOLVED, FURTHER,** that copies of this resolution be furnished the Office of the President of the Republic of the Philippines and other agencies like the Department of Social Welfare and Development, Department of Agriculture, National Disaster Coordinating Council, for their immediate information.
