RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN THE CONTRACT OF AFFILIATION TO BE EXECUTED BY AND BETWEEN BAGO CITY COLLEGE, BAGO CITY HOSPITAL AND THE CITY HEALTH OFFICE FOR THE AFFILIATION AND TRAINING OF HEALTH CARE SERVICES NCII STUDENTS OF BAGO CITY COLLEGE SUBJECT TO POLICIES, PROCEDURES, AND GUIDELINES GOVERNING AFFILIATION AND TRAINING OF STUDENTS IN THE DEPARTMENT OF HEALTH, RURAL HEALTH UNITS AND OTHER HEALTH AGENCIES.
