RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF AGRICULTURE, REGIONAL FIELD UNIT VI, CITY GOVERNMENT OF BAGO AND MAILUM ORGANIC VILLAGE ASSOCIATION FOR PROVIDING ONE (1) UNIT CASSAVA GRANULATOR AS GRANT FOR THE LOCAL GOVERNMENT UNIT.
