MICHAEL JOHN JARDELEZA FOR HIS SERVICES AS A LICENSED ANESTHESIOLOGIST AND TO PRACTICE HIS PROFESSION AT BAGO CITY HOSPITAL IN COORDINATION WITH THE MEDICAL OFFICERS/SURGEONS AND USE THE FACILITIES OF THE HOSPITAL FOR HIS PRIVATE PRACTICE.
