RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND MAGIC DISCO SOUND SYSTEM FOR THE SERVICES OF LIGHTS AND SOUNDS (FULL SOUND SYSTEM SET-UP, ADDITIONAL SPECIAL LIGHTINGS AND POWER GENERATING SET, 162 KVA SILENT TYPE) IN CONNECTION WITH THE "6TH LIGHTS OF BAGO 2014 ON JANUARY 1, 2014 WITH LIVE BAND AT NEW YEAR'S PARTY AT THE BANTAYAN PARK.
