RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DEPARTMENT OF HEALTH CENTER FOR HEALTH WESTERN VISAYAS FOR THE ASSISTANCE IN THE IMPLEMENTATION OF HEALTH FACILITIES ENHANCEMENT PROGRAM (HFEP) WHICH SHALL BE USED FOR THE CONSTRUCTION, EXPANSION, REPAIR/RENOVATION AND UPGRADING OF HEALTH FACILITIES OF THE DOH AND LOCAL GOVERNMENT UNIT PARTICULARLY INTENDED FOR THE CONSTRUCTION OF SEWAGE TREATMENT PLANT AND SOLID WASTE OF BAGO CITY HOSPITAL.
