FOR THE DONATION OF A PARCEL OF LAND COVERED BY TRANSFER CERTIFICATES OF TITLE (TCT) NUMBERS 22275 AND 22276 BOTH SITUATED AT BARANGAY CALUMANGAN, BAGO CITY, NEGROS OCCIDENTAL.
