RESOLUTION RECOMMENDING TO THE LOCAL CHIEF EXECUTIVE TO APPROVE THE REQUEST OF MS. CARMELITA R. SALAS, EXECUTIVE DIRECTOR OF RAFAEL SALAS PARKS AND NATURE CENTER FOUNDATION, INC., FOR TEMPORARILY ACCOMMODATIONS AT THE BUENOS AIRES HOSTEL AND TO URGE THE CHIEF EXECUTIVE TO GRANT THIS TO HER FOR FREE IN CONSIDERATION OF HER SERVICES TO THE CITY ONLY FOR THE DURATION OF THE RENOVATION OF THE RAFAEL M. SALAS PAVILION.

WHEREAS, Ms. Carmelita R. Salas has been serving Bago City by facilitating the donation of funds for the renovation of the Pavilion at the Rafael M. Salas Parks and Nature Center and at the same time acting as a hands-on supervising consultant in the on-going work for several months already;

WHEREAS, it is much easier for Ms. Salas to be nearer the Rafael M. Salas Parks and Nature Center as the renovation is going on;

WHEREAS, Ms. Salas requested that she be allowed temporary accommodations, specifically at Room "8" and the adjacent room at the Buenos Aires Mountain Resort Hostel;

WHEREAS, after a thorough deliberation on the matter, it is the consensus of this body to recommend to the Local Chief Executive that the request of Ms. Salas for temporary accommodations be granted and to grant this accommodations for free only for the duration of the renovation of the Rafael M. Salas Pavilion;

NOW, THEREFORE, upon motion of SP Member Ma. Josefa Y. Matti, duly seconded by SP Member Andrew Martin Y. Torres, the Sanggunian

RESOLVES, as it is hereby resolved, to recommend to the Local Chief Executive to approve the request of Ms. Carmelita R. Salas, Executive Director of Rafael Salas Parks and Nature Center Foundation, Inc., for temporarily accommodations at the Buenos Aires Hostel and to urge the Chief Executive to grant this to her for free in consideration of her services to the city only for the duration of the renovation of the Rafael M. Salas Pavilion.
