**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT – VI AND THE CITY GOVERNMENT OF BAGO FOR FUND ALLOCATION INTENDED FOR THE IMPLEMENTATION OF VARIOUS AGRICULTURAL PROGRAMS/PROJECTS IN THE AMOUNT OF SIX MILLION PESOS (P6,000,000.00) PURPOSELY FOR THE CONCRETING OF 610 METERS FARM-TO-MARKET ROAD OF BRGY. MALINGIN-ATIPULUAN ROAD SECTION IN BRGY. MALINGIN, BAGO CITY.**
