RESOLUTION DISAPPROVING ORDINANCE NO. 2014-002 RE: "BARANGAY REVENUE CODE" AND ORDINANCE NO. 2014-004 RE: "PROHIBITING THE LITTERING OR SCATTERING OF SOLID WASTE" OF BARANGAY MAILUM, THIS CITY.

WHEREAS, presented in the last session assembled are the Ordinances of Barangay Mailum, this City, for review, namely:

1. Ordinance No. 2014-002 re: "Barangay Revenue Code"
2. Ordinance No. 2014-004 re: "Prohibiting the Littering or Scattering of Solid Waste"

WHEREAS, the matter was referred to the Committee on Laws, Rules and Procedures, Committee on Barangay Affairs and Committee on Ways and Means and after a thorough study of the Ordinances, the members of the Committee is of the consensus to disapprove Ordinance No. 2014-002 re: "Barangay Revenue Code" as well as Ordinance No. 2014-004 re: "Prohibiting the Littering or Scattering of Solid Waste", due to some provisions that does not conform with existing laws;

WHEREAS, after deliberation on the matter, it is the consensus of this assembly to disapprove the said Ordinances specifically Section 2A.05 (a), Section 2A.05 (d), Section 3A.07 of the Barangay Revenue Code and Section 10 (c) of Ordinance Prohibiting the Littering of Scattering of Solid Waste, without prejudice to refilling the same; see attached Committee Report for reference and information for the Barangay Council of Mailum;
