RESOLUTION REQUESTING THE OFFICE OF THE CITY VETERINARIAN, THIS CITY, FOR THE STRICT ENFORCEMENT OF THE ANIMAL CODE PARTICULARLY MATTERS REGARDING STRAY DOGS.

WHEREAS, in session assembled, Councilor Bernadette M. Somcio in her privilege speech discussed matters on stray dogs at Barangay Ma-ao, this city;

WHEREAS, Barangay Officials and residents in the area conducted a "Pulong-Pulong" last March 29, 2014;

WHEREAS, residents complained about many stray dogs roaming on the streets which is a serious health hazard for the community;

WHEREAS, after deliberation on the matter, it was the consensus of this assembly to request the Office of the City Veterinarian to strictly enforce the Animal Code of the City, concerning stray dogs;

RESOLVED, as it is hereby resolved, to request the Office of the City Veterinarian, this city, for the strict enforcement of the Animal Code particularly matters regarding stray dogs.
