NEGROS OCCIDENTAL FOUNDATION, INC. FOR A FINANCIAL ASSISTANCE TO INDIGENT PATIENTS OF BAGO CITY HOSPITAL ON EMERGENCY AND IN-PATIENTS INTENDED FOR MEDICINES, MEDICAL SUPPLIES, LABORATORY AND X-RAY PROCEDURES.
