RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE RFU-VI AND THE CITY GOVERNMENT OF BAGO FOR THE ALLOCATION OF FUNDS AMOUNTING TO SIX MILLION PESOS (P 6,000,000.00) INTENDED FOR THE IMPLEMENTATION OF VARIOUS PRIORITY ACTIVITIES/INTERVENTIONS UNDER THE AGRI PINOY PROGRAM.
