**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A LETTER OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES – REGION VI AND THE CITY GOVERNMENT OF BAGO FOR A COMPREHENSIVE SITE DEVELOPMENT (CSD) FOR SEEDLING PRODUCTION, PLANTATION ESTABLISHMENT AND MAINTENANCE AND PROTECTION OF 10.0 HECTARES URBAN GREENING LOCATED AT BARANGAYS DULAO, LAG-ASAN, MA-AO, MALINGIN AND SAMPINIT.**
