**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND CENTRAL NEGROS ELECTRIC COOPERATIVE, INCORPORATED FOR THE CONVERSION OF 5-SPAN OPEN SECONDARY LINE TO 1-PHASE PRIMARY LINE, EXTENSION OF 1-SPAN 1-PHASE PRIMARY LINE, INSTALLATION OF 1-15 KVA DISTRIBUTION TRANSFORMER TOGETHER WITH ITS ACCESSORIES AND STRINGING OF SERVICE WIRE FOR SANITARY LANDFILL AT PUROK PANDAN, BRGY. MA-AO, BAGO CITY, NEGROS OCCIDENTAL.**
