RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A LETTER OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES – REGION VI AND THE CITY GOVERNMENT OF BAGO FOR THE THREE (3) YEARS MAINTENANCE AND PROTECTION OF 10.0 HECTARES URBAN GREENING LOCATED AT BARANGAYS DULAO, LAG-ASAN AND SAMPINIT.

WHEREAS, letter dated July 22, 2014 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in a Letter of Agreement to be executed by and between the Department of Environment and Natural Resources – Region VI and the City Government of Bago for the three (3) years maintenance and protection of 10.0 hectares Urban Greening located at Barangays Dulao, Lag-asan and Sampinit;
