T-19042, T-14829 AND T-19041, WITH A TOTAL AREA OF 38,997 SQUARE METERS, MORE OR LESS ALL SITUATED IN BARANGAY BALINGASAG, THIS CITY AND LIKewise THANKING THE DONOR FOR HIS BENEVOLENT ACT.
