**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE-REGION VI AND THE CITY GOVERNMENT OF BAGO FOR A CONVERGENCE INITIATIVE THROUGH PROVISION OF LIVELIHOOD PROJECTS (SWINE, GOAT, CATTLE AND CARABAO BREEDER STOCK) TO AUGMENT FARMER'S INCOME.**
