**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL, THE CITY GOVERNMENT OF BAGO, HIMAMAYLAN, KABANKALAN, MUNICIPALITIES OF PULUPANDAN, VALLADOLID, SAN ENRIQUE, PONTEVEDRA, HINIGARAN, BINALBAGAN, ILOG, KABANKALAN-HIMAMAYLAN-ILOG INTEGRATED AREA MANAGEMENT COUNCIL, CENTRAL NEGROS COUNCIL FOR COASTAL RESOURCES DEVELOPMENT, PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE, CPSU, USLS, CHMSC AND THE PHILIPPINE BIODIVERSITY CONSERVATION FOUNDATION, INC. FOR AN ALLIANCE SHALL BE KNOWN AS THE NEGROS OCCIDENTAL COASTAL WETLANDS AREA MANAGEMENT ALLIANCE (NOCWAMA) FOR THE PROTECTION OF NEGROS OCCIDENTAL COASTAL WETLANDS AREA**

**WHEREAS**, letter dated July 28, 2014 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and among the Provincial Government of Negros Occidental, the City Government of Bago, Himamaylan, Kabankalan, Municipalities of Pulupandan, Valladolid, San Enrique, Pontevedra, Hinigaran, Binalbagan, Ilog, Kabankalan-Himamaylan-Ilog Integrated Area Management Council, Central Negros Council for Coastal Resources Development, Provincial Environment and Natural Resources Office, CPSU, USLS, CHMSC and the Philippine Biodiversity Conservation Foundation, Inc. for an alliance shall be known as the Negros Occidental Coastal Wetlands Area Management Alliance (NOCWAMA) for the protection of Negros Occidental coastal wetlands area;

**RESOLVED**, as it is hereby resolved, to authorize the Honorable City Mayor to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and among the Provincial Government of Negros Occidental, the City Government of Bago, Himamaylan, Kabankalan, Municipalities of Pulupandan, Valladolid, San Enrique, Pontevedra, Hinigaran, Binalbagan, Ilog, Kabankalan-Himamaylan-Ilog Integrated Area Management Council, Central Negros Council for Coastal Resources Development, Provincial Environment and Natural Resources Office, CPSU, USLS, CHMSC and the Philippine Biodiversity Conservation Foundation, Inc. for an alliance shall be known as the Negros Occidental Coastal Wetlands Area Management Alliance (NOCWAMA) for the protection of Negros Occidental coastal wetlands area.
