RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT-REGION VI AND THE CITY GOVERNMENT OF BAGO FOR THE SALINTUBIG AND TO NEGOTIATE AND SIGN THE CONTRACTS FOR THE PROJECT IMPLEMENTATION AND EXPRESSING COMMITMENTS TO COMPLY WITH THE SALINTUBIG REQUIREMENTS.
