RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE LETTER OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REGION VI FOR A COMPREHENSIVE SITE DEVELOPMENT (CSD) FOR SEEDLING PRODUCTION, PLANTATION ESTABLISHMENT, AND MAINTENANCE AND PROTECTION COVERING A PERIOD OF THREE (3) YEARS FOR THE 10.0 HECTARES URBAN GREENING LOCATED AT BARANGAYS DULAO, LAG-ASAN, MA-AO, MALINGIN, AND SAMPINIT, BAGO CITY
