RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND VILLANUEVA CLINICAL LABORATORY & POLYCLINIC FOR ITS SERVICES TO CATER THE REQUEST FOR LABORATORY TESTS/EXAMINATIONS WHICH ARE NOT AVAILABLE AT THE BAGO CITY HOSPITAL LABORATORY AS A REQUIREMENTS FOR THE RENEWAL OF THE LICENSE OF THE BAGO CITY HOSPITAL WITH THE DEPARTMENT OF HEALTH.
