RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DEPARTMENT OF AGRICULTURE RFU-VI FOR PROVIDING FUNDS TO THE CITY OF BAGO AMOUNTING TO FIVE HUNDRED THOUSAND PESOS ONLY (PHP 500,000.00) INTENDED FOR THE IMPLEMENTATION OF SWINE CHAIN PROJECT UNDER THE BOTTOM-UP BUDGETING (BUB) PROGRAM.

WHEREAS, letter dated November 18, 2014 from the Honorable City Mayor, respectfully referred to this Honorable Body for the passage of a Resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and Department of Agriculture RFU-VI for providing funds to the City of Bago amounting to Five Hundred Thousand Pesos Only (Php 500,000.00) intended for the implementation of Swine Chain Project under the Bottom-Up Budgeting (BUB) Program;
