RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, THROUGH THE ENVIRONMENTAL MANAGEMENT BUREAU 6, DEPARTMENT OF ENERGY, PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL, CITY GOVERNMENT OF BAGO, MUNICIPALITY OF MURCIA, BARANGAY LOCAL GOVERNMENT OF MINOYAN, BARANGAY LOCAL GOVERNMENT OF MAILUM, MA-AO PARISH HUMAN DEVELOPMENT FOUNDATION INCORPORATED AND ENERGY DEVELOPMENT CORPORATION FOR THE CREATION OF THE MULTI-PARTITE MONITORING TEAM FOR THE PROPOSED NORTHERN NEGROS GEOTHERMAL PROJECT AND PROVIDING FUNDS THEREOF.
